INDEPENDENT CHAIR FOR EXTRA-ORDINARY GENERAL MEETING

The Company refers to the forthcoming shareholder extra-ordinary general meeting (EGM) convened by Mr Lewis Tay to be held on 21 March 2011, and at which proposed resolutions will be put to Dynasty's shareholders for the removal of Messrs Ian Levy, Malcolm Carson, and Graham Anderson as directors of Dynasty.

The Company's directors have unanimously resolved:

1. that certain steps are taken so that Mr Stephen Penrose, an experienced lawyer who is independent to the board, chair the EGM;
2. that at the commencement of the EGM, to recommend that shareholders resolve to appoint Mr Penrose as chair of the EGM.

Under the Company's constitution, shareholder meetings can only be chaired by a director or shareholder. To facilitate Mr Penrose chairing the EGM, the Company has issued a share to him. Attached is the appendix 3B.
